NAME

TERMS AND CONDITIONS

- 1. The college reserves the right to accept or reject any applications for admission.
- 2. The college will operate in accordance with the stipulations and requirements of the Regulatory Bodies of the country. Other than delivery of programmes as an obligation to a student by acceptance of enrolment, in no event will the college be liable for any damages, including direct, indirect, special, incidental or consequential damages, expenses or loss arising in connection with the enrolled programme; or the inability to use by any party or in connection with any failure of performance, error, defect, interrruption in the operation of the programme; or arising from or in connection with any fraud or dishonest conduct of any third party, even if the college has been advised of the possibility of such damages, losses or expenses.
- 3. The offer of a place is made on the understanding that admission based on Forecast Results is CONDITIONAL pending the student's actual results (ie. SPM, UEC, '0' Levels). A student's place in the programme will only be confirmed upon receipt of his/her actual results, provided that said results satisfy the entry requirements as stipulated by Equator College. Students who fail to meet the entry requirements are either withdrawn from the programme or enrolled in a programme with lower entry requirements.
- 4. Upon acceptance of the offer of a place and upon the payment of fees, a binding contract is created whereby the student shall abide by the rules and regulations of Equator College.
 - a. New student fees must be fully paid BEFORE the commencement date of semester / term.
 - b. Existing student a late payment charge of MYR 100.00 plus MYR 10.00 per day will be imposed commencing from the 7th working day. Equator College reserves the right to review the status of the student and to take such necessary action as it deems fit, including but not limited to deregistration from subjects enrolled, barring from classes and facilities, suspension, and withholding of all examination results, certificates and records.
 - c. A re-instatement fee will be imposed on eligible students who wish to revert to their enrolled status.
- 5. All fees are subject to change without prior notice. Changes in fees will normally take effect in January.
- 6. Eligibility to sit for the examination depends on the following:
 - a. Fulfilment of attendance requirements of 80%.
 - b. Satisfactory performance in assignments and other stipulated coursework.
 - c. Full payment of tuition and other related fees.
- 7. The college, its staff and any other persons authorised by the college shall not be liable or responsible for any damage to property, personal injury or loss of personal belongings whatsoever and howsoever sustained or suffered by the student.
- 8. The college reserves the right to dismiss a student if his/her conduct is such that his/her continued presence would be detrimental to the running of the programme and/or the good name of the college. There shall be no refund (except refundable deposits) if a student is expelled from the college due to academic misconduct or disciplinary behaviour.
- 9. The application and registration fee is payable at the time of registration. Fees are not refundable, non-transferable and cannot be deferred.
- 10. The college reserves the right to defer or not to commence any programme, and to review, change and update subject curriculum in any programme as it deems fit and necessary.
- 11. International student confirmation of enrolment to the college will be subject to the student fulfilling the terms and conditions imposed by the Immigration Department of Malaysia and the Ministry of Education Malaysia.
 - a. All International Students are required to pay the following fees upon registration:
